We, the undersigned, have read, understand and accept the Rules and Regulations governing the North Shore Premier Player Program ("the NSPPP") as amended from time to time, and the NSPPP Privacy Policy as published on the NSPPP web site ([www.nsppp.com](http://www.nsppp.com)). In addition we agree to and acknowledge the following:

1. That the NSPPP registration fee for the 2010 / 2011 season is not refundable if for any reason the player voluntarily leaves or is directed to leave the NSPPP. The cost of any uniform / kit items not included in the registration fee is the responsibility of the player.
2. That continued participation by a player in the NSPPP is dependent upon the player's continuing commitment and his positive contribution to the NSPPP (including his attendance) as measured by the coaching staff and the NSPPP Committee. Players will be directed to leave the NSPPP at sole discretion of the NSPPP Committee if the player's commitment and positive contribution is lacking in respect of the NSPPP.
3. That the NSPPP Committee will reassign players within age group teams where the Team Coach or Technical Director makes such a recommendation and where permitted by the rules of the BC Youth Select Soccer League ("BCYSSL").
4. That the NSPPP is a player development program that is based on player performance. Lack of respect for the Rules & Regulations of the NSPPP, the Coaches, Manager, parents or other players may result in probation, suspension or removal from the NSPPP.
5. That a player who's conduct is unbecoming to the player or detrimental to the reputation of the NSPPP which includes but is not limited to inappropriate or violent behavior may be removed from the NSPPP.
6. That any decisions of the NSPPP Committee are final and binding upon the player.
